Dear Grower,

Your 2022 Field Application is enclosed. Be sure to fill in all blanks completely except for the field number column, which we will assign in the office. Also, please enclose your check for the total amount, including the \$150.00 Membership Fee (unless you have already paid the fee for 2022). Please remember that field inspection fees are due with your application. **Fields will not be walked until the CSGA Office has received a complete Application with payment.**

When you draw your field maps, please use the separate field map sheet. Draw the map so that a person who has never been to your farm could find the field. Please do not leave the mapping portion blank or indicate that someone will show the inspector where the field is. A good map is needed in case the inspector cannot meet with you. **Also, if you know the GPS coordinates of your field, please include those on the Application.**

Be sure to include proper source information for the planted seed (bag tag, copy of bulk sales certificate, or transfer form). This documentary information is required by section IV. of the General Standards.

The Colorado Seed Growers Association is committed to promoting quality seed, and it is imperative for the fields to be in good shape. Please do not include any fields that you do not intend to properly manage for the production of high-quality seed. As always, it is your responsibility to make sure the fields are in good shape before the inspector arrives. If you feel your weed control program is not up to standard by the time of inspection, you may cancel the field and be refunded your field inspection fees. **Note:** Inspection fees cannot be refunded once the Inspector has walked the field, except in cases of natural disaster (i.e. hail). It is important to call the Office 10-14 days before your fields are ready for harvest, so we can have an inspector there in a timely manner.

Thanks for your hard work in maintaining the credibility and high standards associated with Colorado Certified Seed. We are looking forward to working with you and hope you have a great growing season!






Field Inspection Maps




